[Current Mayor and Deputy-Mayor are not running in this fall election. Current Councillor, Walt McKechnie, has been acclaimed as the incoming Deputy-Mayor. New local Councillor was also acclaimed. The new council is to be sworn in Nov 15.)

Murray Fearrey, Mayor Elect

-Members had raised issues of By-laws (e.g., fireworks) – difficult to enforce, fines are minimal.

Murray:

- staffing is a problem, need to take pictures in some cases to send in to by-law officer
- Camping on properties trailers (limited period)
- rentals related to Air B and Bs owners not present, number of people staying no control
- Septic systems inspections
 – important to update systems (also triggered by rentals as noted above), some of these systems are overused

Walt McKechnie, Deputy Mayor Elect

-County Shoreline Preservation By-Law

-Walt discussed issues with the Shoreline By-law – was passed quickly, complicated, what level of protection it provides is questionable. He stated he was not in favour (Dysart County did not support it).

Importance of Septic Inspections

Anna gave a very brief overview of the Dysart septic inspection program. There are a number of areas which require clarification and perhaps adjustment in the program.


